Project Summary

The project aimed to regenerate the park to achieve the following:

- Enhance the site by planting an under-storey for the remnant trees in the park to provide increased habitat for native wildlife
- Create nature play spaces throughout the park where children from nearby schools can play and learn to recognise different native species and plants common to the ACT
- Create an enhanced natural setting for the community to enjoy which will encourage community use and participation

The park was divided into sectors planted out with ACT native shrubs, wildflowers and grasses thereby replacing the mown under-storey of exotic grasses and weeds in these areas, in particular Chilean Needle Grass. Several natural sandstone blocks were placed in the garden beds as seating and plants were interspersed with rocks and logs to provide increased habitat. The grant originally covered an additional 500m2 of planting area, however this has been exceeded.

The whole plan was implemented over several years as funds became available.

Both adjacent schools have reached out with requests for using the park as an educational resource. Teachers from St Thomas More's Primary School undertook a Professional Development session, led by a local indigenous guide, walking through the gardens, identifying the plants and describing their use and importance to the local Aboriginal people.

Planning for activities with the kindergarten class from the Campbell Primary School are underway and should take place next year.

This grant allowed us to expand on a previous start up grant from TCCS.

If the project didn't achieve the activities and milestones required please describe why?

The project has achieved the activities and milestones required but not within the reporting period of the grant. This is due to a number of factors:

- Covid lockdowns and restrictions
- The system used for site preparation involves spraying then mulching and planting through the mulch. Both the spraying and the planting have a small window of time when conditions are optimal for success. Spring/early Summer when the weeds are actively growing and late Winter/early Spring for plant growth.
- Dependent on TCCS to provide mulch for the project. Delays meant a slowing of the site preparation and planting. This led to a request for some of the grant monies to be used to buy mulch commercially.
- We were lucky enough to be successful in winning and Adopt a Park grant at around the same time. This grant was fundamental in allowing us to continue to expand on the area to be planted out and furthering the aims of the project, but also extended the time taken to do the work
- The local developer withdrew from the agreement to provide rocks free of charge for the project. Rocks were purchased.

What Outcomes were generated by your project?

- The park has been changed visually by the project and there is anecdotal evidence that there is increased community use of the park. All comments regarding the project and the progress to date have been positive.
- Underplanting of garden beds has allowed timber to safely fall and remain in place, thereby returning carbon to the soil.
- Planting and mulching have created a richer soil layer and eased the compaction created by regular mowing.
- The biodiversity of the site has increased due to the planting of an under-storey around the remnant trees.
- The planting of native wildflowers has seen an increase in native insect pollinators.
- Thick plantings across the slope of the site have slowed runoff and accumulation of water in low points. It is expected that there will be further decreases in runoff as the area under planting increases.
- The project has led to a decrease in the area requiring regular mowing.
- The volunteer group numbers fluctuate however the vision for the park has been welcomed by the Campbell community. Our Caring for the Land regular working group also acts as an opportunity for people to come together to enjoy each other's company and to appreciate how the project is changing the park into a much more enjoyable space.
- While there has been some weed breakthrough, the overall effect of the project has been a marked decrease in the amount of weeds in the treated and planted sites. This is particularly true for the Chilean needle grass.
- 10-15 new eucalypts have come up in the planted areas. While it is unlikely they will grow to maturity, they still provide valuable habitat.
- It is noted that some native wildflowers and grasses have spread outside the planted sectors, which is what was hoped would happen. In one of these areas the beds have been extended to protect these plants from future mowing.

How did you track these outcomes?

The biodiversity of the site has increased due to the planting of an under-storey around the remnant trees. ACT Wildlife has also used the beds as a release site for an injured blue tongue lizard from the Campbell area. Superb parrots and gang gangs continue to be regular visitors and rosellas have been observed checking out tree hollows for nesting (this has not happened yet but it is hoped that as the trees are further protected by the garden beds that this will be even more attractive as a nesting site).

Site assessment prior to starting ground work: Professor Mulvaney's original report said that the site comprised about 70% of the mown understorey: "The mown understorey is almost entirely composed of exotic species, with around 70% of the understorey composed of Chilean Needlegrass (Nasella neesiana) a major environmental weed. The understorey

has very little wildlife value, while the mowing is preventing any natural regeneration of the remnant trees.

The planting of native wildflowers has seen an increase in native insect pollinators and photos of these have been added to the Park's NatureMapr site for identification and recording on the Park's dedicated NatureMapr site.

Anecdotal evidence of social engagement:Trish, one of the regular volunteers, wrote the following: "My husband and I were keen to become involved in the local community when we moved from Brisbane to Campbell in late 2019. Working in Violet McKenzie Park has not only provided an activity that we can enjoy together but has also led to the development of friendships within the group. In addition to the social benefits we have both learnt so much about this area's history and ecology and feel a sense of pride in what this group is achieving...."

Where any of your outcomes unexpected? If so why?

When we first met with the Molonglo Conservation Group MCG in 2019 we spoke about the dramatic infill of green spaces in the suburb of Campbell. We spoke of our concern about losing the park in Campbell to development. MCG advised us to think about ways of claiming the park for the community and for the environment. We were advised to engage with the local schools and businesses located near the park. We didn't expect to generate the depth of engagement we have, and that four years later the community and the government were still engaging with us in the park.

While we were confident this would always be a worthwhile project we didn't expect the park to be the setting for the launch the 2024 ACT Environment grants.

The fact that the park is now recognised as a potential refuge for rehabilitating injured wildlife is an unexpected testimony to our claimed outcomes.

Dealing with challenge

Were there any challenges encountered and, if so, how did they influence the outcomes?

A major challenge to the success of the project has been with mulch delivery. When sprayed, we have found that the mulch needs to be spread within 2 weeks to maximise the suppression of weeds. Either the mulch delivery process needs to be more reliable or extra funding allowed for purchase of commercial mulch.

The presence of critical underground infrastructure running through the park required a professional survey of the area as a DBYD report could not guarantee that it would all be identified or that the position of the infrastructure was accurate.

It is understood that there is only one contractor delivering mulch and logs. At a couple of critical times in the planting, mulch was ordered from commercial suppliers who delivered it within 3 days. A professional surveyor was hired to do a survey of the park's underground infrastructure.

It is hoped that the project will be able to continue until all of the remnant trees are protected by under-storey plantings and that the majority of the park area will be covered by ACT native species. Not only will this increase the biodiversity in the park, it will decrease the amount of exotic weeds and the necessity for regular mowing and lessen the heat island effect. It will also increase the connectivity between the Mt Ainslie and Mt Pleasant reserves. Must be no more than 100 words.

Lessons Learned

What did you learn as a result of undertaking this project?

Geographic setting was right and would encourage others to do similar projects in their local urban parks. Covid threw a lot of our timing out, but we probably underestimated fluctuations in volunteer numbers, extensive maintenance or planting time, delays in mulch delivery and seasonal spraying. Was always confident that the project would a worthwhile

community project, and this has proven to be right. The extra skills required for project management were also a not anticipated eg annual first aid training, Chemcert certification. Additional time not initially factored in included plant selection, picking up plants, preparing for working bees, admin.
