

The project for the reprinted interpretive signs in the Forest Loop Walk will:

1. Enhance awareness of the condition and connectivity of the woodlands and forests of ACT including Black Mountain.

2. FoBM has a weeding program which would enhance the condition of the area, by removal and control of weeds that threaten the natural biodiversity near the Forest Loop Walk.

3. The project will enhance community understanding of this area and its biodiversity that is close to the city and inner suburbs. The interpretive signs, including indigenous art will highlight the biodiversity of the site and the Ngunnawal use of relevant plants in the area.

4 A self-guided walk of the nearby areas will be available electronically and by print on demand.

5. FoBM, MCG and Ngunnawal representative are all community organisations that will be involved in the content and design of the work and in leading guided walks about the site, its relationship to the green corridor of the area, and assisting community understanding of the natural biodiversity of this site and the Black Mountain Nature Reserve in general and its continuity with the nearby reserves. Similar walks in other parts of the re-serve have been successful and very positive feedback has been received.

6. People will be connected to nature by greater understanding of the flora and fauna of the site through the interpretive signs. On similar guided walks in other parts of the reserve, the participants have enjoyed doing the self-assessment quiz. Their very positive feedback has highlighted how much the learnt and remembered of the biodiversity observed during the walk, and they found the information and quiz was a useful reference for conversation with others soon afterwards. A quiz also provides an opportunity to engage with younger members of a family group that may participate in the walks.

7. As the Forest Loop Walk is one of the more high-profile walks on the mountain, we are hoping that by re-printing the interpretive panels it will assist understanding by those who are doing self-guided walks and making this area more attractive and educative, it will encourage people to explore other areas of the mountain. This includes locals and interstate and international tourists. The recently announced redevelopment of Telstra Tower will only increase the likely patronage of the area, adding to the importance of having a pleasant and informative experience while on the Forest Loop Walk.

8. The project will recognize Caring for Country by involving the Ngunnawal people in various ways, including the art work and being involved in the guided walks. Other ACT Indigenous representative groups will also be consulted.

9. The ACT Government Minister for Environment will be invited to officially launch the reprinted signs and e-links to digital data. Other active members of associated community groups will also be invited.

The Forest Loop Walk is approximately 2km long, and the interpretive signs are located at pertinent locations along the walk.

Several hundred woody and other weeds in the site will be removed. A record of this information and the voluntary effort will be included in the progress and final report of the project.

Photos will show the current condition of the signs and how that has improved after the project.

Installation of the upgraded interpretive signs and Ngunnawal art posts will provide relevant information and digital links about the biodiversity of the site. Leaflets available will satisfy the need for information to be avail-able in different formats.

There is strong community awareness of Black Mountain, and with the Forest Loop Walk

We expect a similar positive response to this initiative.
